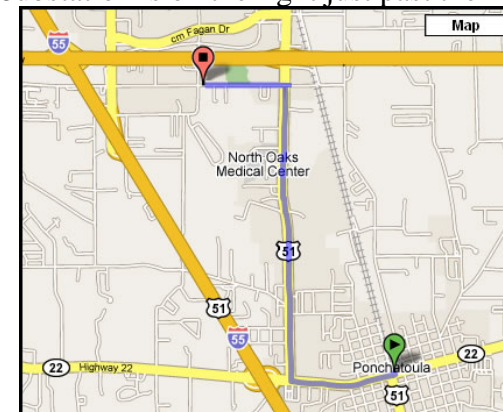

4. Turn **left** at **Club Deluxe Rd** - go **0.6 mi**
